If you want to explore the exciting world of aviation, or consider making it a career, then there is no better place to start than with the Malta School of Flying Induction Course. With no entry requirements, the course is ideally suited for students between 10 to 15 years.

The course is held during July and August, on Mondays and Thursdays from 08:30 to 13:30 and comprises fifteen sessions.

The course provides background knowledge of the subjects taught in the Private Pilot Licence course, with topics such as Communications, Air Law, Human Performance and Pilot Limitations, Aircraft Technical, Meteorology, and Navigation. The course is performed by a professional instructor according to the following schedule:

- Introduction
- Aviation history
- Jobs related to flying and aviation
- Academic Requirements
- Components of an airplane
- Aerodynamics
- Power-plants
- Aircraft systems
- Flight instruments
- Flight safety
- Airport environment
- Aeronautical charts
- Communications and air traffic services

- Aircraft performance
- Weight and balance
- Aviation in general
- Tests
- Certificate presentation



Various media and videos are used during the lessons. Besides lectures, the course includes visits to various aviation related sites such as the Air Traffic Control Centre, the Airport Fire Section, the Meteorological Office and a Maintenance Facility. Visits are subject to Covid 19 restrictions. Finally, the highlight of the course is a thirty-minute trial flight on Tecnam P9JS2 or P2002JF, where students have the opportunity to perform a flight under the supervision of an instructor.

The total cost of the course including lectures, visits and the flight is just €495. Early bird rate of € 460 applies for payments made before the end of March.

The course also counts for school extra-curricular activities and students can have their forms signed at the end of the course.
